4. Problems in translating the story

It is not merely a work finding lexical equivalents i.e., TL equivalents of SL words, but much more, as it involves cultural, aesthetic, ethical, social, scientific and metaphysical dimensions of SL and TL. She questions why a woman cannot tell her husband that it is her house if he likes he can live otherwise he can leave. She further questions why they are unable to digest if she tries to live in 'her' house. That is a crucial question to the society where women are deprived of several rights as equal.
