Launched in 2006, the initiative seeks to eliminate caste-based discrimination and foster social equality through the construction of integrated residential clusters. These clusters, referred to as Smathuvapurams, are designed to house people from diverse backgrounds, offering them equal access to resources and infrastructure such as schools, healthcare centers, parks, and community halls. The scheme's core objective is to create a model of social fraternity and equality, where individuals can live together peacefully, transcending their caste, religion, and social status. Financial assistance, including land allotment and subsidies for house construction, was provided to beneficiaries, with an emphasis on voluntary participation and mixed-community living. Despite facing challenges in fully realizing its vision, the Smathuvapuram scheme remains a groundbreaking initiative in Tamil Nadu's ongoing efforts to promote social justice and integration. The project serves as a model for other regions and aims to inspire nationwide social reforms, reinforcing Dr. Karunanidhi's vision of an egalitarian society.

The Smathuvapuram project aims to create settlements in which people from all walks of life can co-exist harmoniously, irrespective of their caste, religion, or social status. The objective was to construct residential colonies with a blend of community services, which would embody a social framework devoid of communal or caste-based divisions. These settlements were constructed across various parts of Tamil Nadu, initially at 50 locations, and later expanded. The government provided land, financial subsidies, and infrastructure support, such as schools, parks, community halls, and healthcare centers, to ensure that the residents of these colonies would live comfortable and dignified lives.

In essence, the Smathuvapuram scheme sought to build more than just houses; it aimed to create a "miniature society" where social harmony, equality, and fraternity could flourish. The underlying objective was the transformation of rural settlements into models of peaceful coexistence.

# Social Change Through Smathuvapuram

The essence of the Smathuvapuram scheme was in its radical attempt to transcend the boundaries of caste. One of the main points of focus in the project was to ensure that the residents of these Smathuvapurams would adhere to principles of social equality, and the cooperation of the people living in these settlements was critical to the scheme's success. Along with the physical infrastructure of roads, sanitation, and education facilities, the larger objective was to create a society where equality prevailed in all aspects of life.

# Implementation and Financial Assistance

The Smathuvapuram scheme was structured in such a way that it encouraged voluntary participation from the people. The government allotted land for free to eligible families, with a plot size of 5 cents per household. Each beneficiary was provided with a subsidy of Rs. 37,000 for house construction, divided into two phases, one for the basic structure and another for roofing. The scheme also provided loans through cooperative banks for the construction of additional amenities in each house.

To avoid segregation, the allocation of land and houses was carefully managed to ensure that no single community was given preference. A diverse mix of families was to be included in each settlement to foster the principles of unity and equality. This was made clear in the guidelines, which emphasized that the allocations must reflect an equal distribution among various communities, including those from lower social strata. The initiative was also designed to ensure transparency, with the final list of beneficiaries being vetted by a committee and approved through public consultations.
