Moreover, the volta, or thematic shift, which traditionally occurs at the ninth line or the final couplet in Shakespearean sonnets, remains a powerful device in modern poetry. The ability to shift tone, perspective, or theme within a compact form enhances a poem's dynamism, and poets across the centuries have harnessed this technique to create poignant and unexpected turns in their work.
