## Causes of Child Labour in Karnataka

Low wages and insufficient job security for adults in sectors like agriculture, construction, and small-scale industries push families to depend on children for survival.
- 5. **Exploitation by Employers**: In industrial sectors, employers may seek to exploit children because they are perceived as cheap and easily controllable labor. Children in these industries are often denied fair wages, work under hazardous conditions, and lack the legal protection that adult workers may receive.
