Prevalence of Crimes Against Women

Rajasthan has consistently ranked among the top three states in India in terms of crimes against women. According to the National Crime Records Bureau (NCRB), in 2020, Rajasthan reported 38,476 cases of crimes against women, accounting for 12.6% of the total cases nationwide. These crimes include:

1. **Rape:** Rajasthan reported 2,044 cases of rape in 2020, with a conviction rate of merely 27.6%.
2. **Domestic Violence:** The state witnessed 14,357 cases of domestic violence in 2020, accounting for 37.3% of the total cases.
3. **Dowry Harassment:** 4,444 cases of dowry harassment were reported in 2020.
4. **Human Trafficking:** Rajasthan reported 255 cases of human trafficking in 2020.

Causes of Crimes Against Women

Several factors contribute to the high incidence of crimes against women in Rajasthan:

1. Patriarchal Society: The state's societal structure perpetuates a patriarchal mindset, where women are often seen as inferior.
2. Low Literacy Rates: Rajasthan's female literacy rate (58.6%) is lower than the national average (64.1%).
3. Economic Dependence: Women's economic dependence on men makes them vulnerable to exploitation.
4. Social Norms: Practices like child marriage, dowry, and honor killings perpetuate violence against women.
